#### **Roads**

• Chair attended CC Chairs' meeting in June. Shared that Giffordtown has been piloting an ipad sized computer to track how many people who are doing excessive speeds.

#### 4WT

Debbie Scollay now Secretary of 4WT

As Board of 4WT comprises members of all 4 CCs it was felt a requirement to review the 4WT itself, how it operated and whether it is reaching the groups it aspires to. E.g. is it reaching Auchtertool? Needs to be a group that has a constitution or accounts.

Encouraged any eligible community groups to apply – requirement for application

Add advert to village website for grants and additional 4WT Board Member. Next grant is November 2025, applications close end of October.

#### **Projects**

- Planters in situ and have looked lovely over the summer
  - Still some money available from \$WT with a view to putting in some bedding plants over winter
  - Shout out to be added to website/billboard for 3-4 gardeners to take this on as an ongoing project

- Senior Christmas/Summer Parties Shout out to be added to website/billboard for 3-4 people to take this on as an ongoing project. For Christmas 2025, hall and caterers are already booked. Chair drafting something to share in village to ensure that this year and will share with Janet Vergo to review before publishing.
  - Entertainment or band still required. Cllrs made suggestions for entertainment that could support budget
  - Potentially sits with one of the village committees Village Hall seems like the best fit in relation to the events
  - 52 seniors have attended recent events. Doesn't have to be a senior citizen that runs it.

#### Village Issues

 Parking on farm track/old railway line/back of Newbigging Terrace, behind opening to sewage works – Cllr asked if this could this be referred to Safer Communities. CJM will review on land map and consider whether any action is required. If private land no action can be taken.
